Janusz Ordovery Named Competition Economist of the Year

Patrick McGeehin Named Construction Expert Witness of the Year

He has served as an expert witness in significant antitrust matters during his career, including *Allied Orthopedic Appliances v. Tyco Health Group*, *In re Hydrogen Peroxide*, *In re LIBOR-based financial instruments antitrust litigation* and *TCL Communication Technology Holdings, Ltd., et al. v. Telefonaktiebolaget LM Ericsson, et al.*
