Prior to joining the SEC staff, Mr. Walker was an auditor at the public accounting firm of Ernst & Young in Detroit, Michigan. Mr. Walker is presently an adjunct professor of accounting in Georgetown University's L.L.M. and J.D. programs. Mr. Walker earned an A.B. from Amherst College and an M.B.A. from The Amos Tuck Graduate School of Business Administration at Dartmouth College. He will work from FTI's Washington, D.C. office.

Linda A. MacDonald, CPA, also joins FTI as a Senior Managing Director in the Forensic and Litigation Consulting segment. Ms. MacDonald's nearly 25 years of diverse professional experience gives her a unique perspective in working with clients to identify, understand and solve critical financial accounting and reporting issues facing companies today. Ms. MacDonald, a certified public accountant, has been a frequent speaker on accounting topics and is a former member of the Technical Standards Subcommittee of the AICPA Ethics Committee. She holds an M.B.A. in finance from American University and a B.A. in economics and management from Albion College. Ms. MacDonald will work from FTI's New York office.
