The software can be deployed behind the firewall with an on-site support team, or the software and services can be managed remotely working with local IT staff. FTI Harvester supports Microsoft SharePoint 2010 as well as earlier Microsoft SharePoint versions, and offers predictable pricing through a simple calculation of data volume and number of custodians

"Because it is replacing or augmenting traditional data stores such as corporate file shares, it is absolutely critical for companies to establish a repeatable Microsoft SharePoint preservation and collection process. A 2009 ESG research study found that while most Microsoft SharePoint deployments were in their infancy, senior executives still claimed that the technology was going to be a top ten IT initiative in 2009 and 2010 (Microsoft SharePoint Adoption, Market Drivers, & IT Impact, Enterprise Strategy Group, March 2009). Yet collecting data from Microsoft SharePoint in response to an e-discovery request poses some particular challenges, including:

- **Keywords:** Microsoft SharePoint search capabilities are not conducive to finding data by custodian, so relevant data modified or accessible by the custodian may be missed. In addition, relying on untested keywords can result in incomplete or overly inclusive collection.
- Decentralized control: IT may not track the subject matter, data formats or even those with access to information residing within Microsoft SharePoint.
- **Dynamic environment:** With Microsoft SharePoint data constantly changing, the collection process must contend with the addition, deletion and changes to that information, as well as organizational staffing changes. As the information changes, companies may run the risk of having to recollect data multiple times to ensure a thorough collection.
- Data formats: Microsoft SharePoint is often used as a storage repository for a vast array of file formats beyond the typical email and Microsoft Office documents most often collected, reviewed and produced for litigation.

"The legal advantage and defensibility provided by custodian-based collection cannot be overstated," said James Zucker, associate for <u>Hogan Lovells</u>. "FTI Harvester is a self-documenting, one-stop-shop, surgical strike collection tool for Microsoft SharePoint."
