Mr. Pace also has significant Foreign Corrupt Practices Act ("FCPA") experience, most recently leading the investigation into allegations of serious corruption in the Chinese operations of a large, multi-national life sciences company; conducting a risk assessment of a global healthcare company's operations and practices in China; conducting an investigation of alleged FCPA violations in Europe and Argentina for a medical device manufacturer; and leading the FCPA pre-acquisition due diligence in Pakistan, Oman, Bangladesh, Egypt, China and Indonesia related to the commercial agents of a target company in the oil and gas sector.
